# Key West, Florida Maximum Non-Consent Towing Rates

Revised 11/8/2011

### **Private Property Non-Consent Tow Rate**

Class A (mopeds, motorcycles, cars, vehicles/vessels weighing 10,000 pounds or less)...	<b>Flat Rate \$100.00</b>
Class B (vehicles weighing 10,001 to 20,000 pounds).....	<b>Flat Rate \$150.00</b>
Class C (vehicles in excess of 20,000 pounds).....	<b>Flat Rate \$360.00</b>
Rate if released on scene.....	<b>50% of Flat Rate</b>

### **Storage Fee.....\$25.00 per Day**

Storage fees may be imposed after the vehicle has been in the care, custody and control of the towing operator for more than 6 hours. Storage fees accrue at rate of \$25.00 per 24 hour period or fraction thereof.

### **Administrative/Lien Fee.....\$25.00 maximum**

Administrative/Lien fee may be imposed after the vehicle has been in the care, custody and control of the towing operator for more than 24 hours. Administration/Lien fees are actual costs of obtaining ownership information not to exceed \$25.00. Tow operator must provide documentation of costs prior to instituting such charge.

### **After-Hour Gate Fee.....\$30.00 maximum**

After-hour gate fee may be imposed after the vehicle has been in the care, custody and control of the towing operator for more than 6 hours. After-hour gate fee is a maximum of \$30.00. After-hour gate fees may not be applied between the hours of 8:00 a.m. and 6:00 p.m. Monday through Friday (excluding federal holidays). After-hour gate fees shall not be imposed if business is open, which includes having vehicles engaged in towing services at the time.

No other charges in excess of these rates/fees established by Key West Commission shall be charged.

Tow services are payable by Cash, money order, valid traveler's check, valid bank debit/credit card including but not limited to MasterCard or Visa.

Police Directed Tow Rates/Fees and Consent Towing Rates/Fees may vary from this rate list.

This established rate sheet shall be posted and given to every person seeking to retrieve a vehicle or vessel.

*If you feel you have been charged in excess of these published rates you may submit a written complaint of the alleged over-charge to the City of Key West Parking Division. The Parking Division will investigate the complaint and any such valid violation shall be punishable in accordance with Section 1-15 of the City of Key West Code of Ordinance.*
