[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

ON 02/25/06 AT APPROXIMATELY 0001 HOURS I WAS ATTEMPTING TO STOP A VEHICLE THAT MATCHED THE DESCRIPTION OF A VEHICLE THAT WAS BEING OCCUPIED BY A SUBJECT BY THE NAME OF OMAR BROWN WHO HAS TWO OUT STANDING WARRANTS FOR HIS ARREST OUT OF MONROE COUNTY.

I ATTEMPTED TRAFFIC STOP ON SR-5 AT MACDONALD AVE ACTIVATING MY LIGHTS AND SIREN. THE VEHICLE THEN DISREGARD MY EMERGENCY LIGHTS AND SIREN MAKING A LEFT HAND TURN ONTO CROSS ST FROM SR-5. THE VEHICLE THEN CONTINUED DOWN CROSS MAKING A RIGHT HAND TURN ONTO FIFTH AVE. THE VEHICLE THEN MADE A RIGHT HAND TURN INTO SUNSET HARBOR TRAILER PARK WHERE THE VEHICLE WAS ABANDONED.

WHO WAS OMAR R. BROWN WHO I WAS LOOKING FOR REFERENCE THE WARRANTS. BROWN WAS ARRESTED REFERENCE THE WARRANTS AND SEARCH INCIDENT TO ARREST IN BROWN FRONT RIGHT POCKET I LOCATED A CLEAR PLASTIC BAGGIE CONTAINING A GREEN LEAFY SUBSTANCE F.T.P. A PERIMETER WAS SET AND DEPUTY AMOLE LOCATED THE SUBJECT IN THE REAR OF THE PROPERTY WHO WAS LATER IDENTIFIED AS LAQUENTON CADE B/M 2/10/77.

CADE WAS ASKED HOW LONG HAS HIS LICENSE BEEN SUSPENDED AND CADE ADVISED THAT TO HIS KNOWLEDGE THAT HE HAS BEEN SUSPENDED AT LEAST FOR ONE YEAR PRIOR TO TODAY.

CADE WAS ARRESTED AND TRANSPORTED TO MONROE COUNTY JAIL REFERENCE FLEEING/ATTEMPTING TO ELUDE POLICE WITH LIGHTS AND SIREN, DRIVING WHILE LICENSE SUSPENDED WITH KNOWLEDGE, AND RESISTING ARREST WITHOUT VIOLENCE. CADE WAS ALSO ARRESTED ON A OUTSTANDING WARRANT OUT OF MONROE COUNTY.






