A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES TO RITA MURPHY FOR AN EVENT TO TAKE PLACE DURING THE HOURS OF 6:00 P.M. TO 10:00 P.M. AT 609 THOMAS STREET ON FRIDAY, APRIL 10, 2009; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 6-86 of the Key West Code of Ordinances requires a Special Event Permit to depart from the requirements of the City's Noise Control Ordinance; and

SECTION 1. That Rita Murphy is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time as herein described.


SECTION 2. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the
