**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES TO THE KEY WEST BUSINESS GUILD FOR AN EVENT TO TAKE PLACE DURING THE HOURS OF 5:00 P.M. TO 11:00 P.M. AT 409 APPELROUTH LANE ON THURSDAY, AUGUST 20, 2009; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Section 6-86 of the Key West Code of Ordinances requires a Special Event Permit to depart from the requirements of the City's Noise Control Ordinance; and

**WHEREAS**, the Key West Business Guild has applied to the City for a Special Event Permit for a Tropical Heat Opening Reception on Thursday, August 20, 2009; and

**WHEREAS**, this event shall take place on the grounds of Big Ruby's Guest House at 409 Appelrouth Lane between the hours of 5:00 p.m. and 11:00 p.m.; and

**WHEREAS**, amplified music will be played during the event;

**NOW THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida:


