(1) Attach diagram and description of outdoor area which is designated for dogs. Must be accurate and to scale.

Must include dimensions; placement and number of tables, chairs, restaurant equipment, entryways and exits to designated outdoor area, boundaries of area, outdoor area NOT available to dogs, fences or other barriers, surrounding property lines and sidewalks.

(2) Attach insurance certificate. Public liability and property damage providing coverage for all claims and damage to property or bodily injury, including death which may arise from the existence of a dog in the establishment. Coverage must be of not less than \$1,000,000 for bodily injury and property damage, per occurrence. City must be named additional insured for any property that business owner leases from the City of Key West. Policy must state that it will not be terminated or cancelled without 45 days written notice sent via certified mail to the Licensing Official of the City of Key West.

(3) Attach approval from code compliance officer that all conditions under code section 109-3 have been met.

Hold Harmless Statement

Please note that the following notices must be in the form of a sign or signs posted in a conspicuous manner to employees and patrons, as applicable.

____ Notice to employees to wash their hands promptly after touching, petting, or otherwise handling any dog(s) and before entering other parts of the public food service establishment from the designated outdoor area.

____ Notice to employees that they are prohibited from touching, petting, or otherwise handling any dog while serving or carrying food or beverages or while handling or carrying tableware.

____ Signage in outdoor areas stating that patrons should wash their hands before eating.

____ Waterless hand sanitizer on all tables in designated outdoor area.

____ All dogs shall wear a current license tag or rabies tag and the patron shall have a current license certificate or rabies certificate immediately available upon request.

____ Notice to employees and patrons that dogs must be on leash at all times and under reasonable control; and that dogs must not come into contact with serving dishes, utensils, tableware, linens, paper products, or any other items involved with food service operations.

____ Notice to employees and patrons that dogs must not be on chairs, tables, or other furnishings; must remain on floor/ground level and shall not be permitted in lap of patron.

____ Notice to employees that they shall clean and sanitize all table and chair surfaces with an approved product between seating of patrons. Employees must remove all dropped food and spilled drink from the floor/ground as soon as possible but in no event less frequently than between seating of patrons at the nearest table.

_____ Notice to employees and patrons that all dog waste shall be removed immediately and floor/ground shall be cleaned and sanitized with an approved product. Employees shall keep a kit with appropriate materials for this purpose near the designated outdoor area.

_____ Notice to employees and patrons that dogs are not permitted in or through the non-designated areas.

_____ Signage notifying the public that the designated outdoor area is available for dogs.

_____ Ingress and egress to the designated area shall not require entrance into or passage through any indoor area or non-designated outdoor portions of the public food service establishment.
