PROJECT DESCRIPTION: THIS PROJECT PROPOSES INFRASTRUCTURE IMPROVEMENTS ALONG GERALD ADAMS / COLLEGE ROAD. ENHANCEMENTS INCLUDE SIDEWALK CONSTRUCTION ALONG BOTH SIDES OF COLLEGE ROAD FROM 40' SOUTH OF SUNSET MARINA ROAD TO 200 FEET SOUTH OF THE FLORIDA KEYS COMMUNITY COLLEGE ENTRANCE WITH CURB AND GUTTER ALONG THE NORTH SIDE OF THE ROAD , AND AT GRADE ALONG THE SOUTH SIDE OF THE ROAD. IN ADDITION, THE PROJECT INCLUDES THE INSTALLATION OF AT GRADE SIDEWALK ALONG KOKENZIE ROAD / GOLF COURSE ENTRANCE TO CONNECT THE PROPOSED SIDEWALK ALONG COLLEGE ROAD WITH THE GOLF COURSE ENTRANCE. ALL THESE SEGMENTS OF SIDEWALK WOULD HAVE ADA COMPLIANT CURB RAMPS AS WELL AS ADA COMPLIANT BUS STOPS. ALSO INCLUDED IN THE PROJECT ARE MISCELLANEOUS SIGNING AND PAVEMENT MARKING UPGRADES TO COMPLEMENT THE INSTALLATION OF THE NEW SIDEWALK SEGMENTS.
