Dear Mr. Carey:

The City is in receipt of your timely submitted application for the Newman Rehabilitation Building Program. Staff has conducted a preliminary review of the application and is requesting the following additional information or clarification regarding the submitted materials:

- Clarify why the architectural fee has gone up from %12 for previous years work to %17 this year.
- Clarify how much of the \$46,818 is wood repair and how much is paint.

This additional information is requested by November 2, 2011.

Your project presentation is scheduled before the Bahama Village Redevelopment Advisory Committee at their regularly scheduled meeting on Thursday, November 3, 2011, starting at 5:30 p.m. Please be prepared to describe the key aspects of your project in 10 minutes or less and to answer questions that may be posed by the board. In addition, staff or board members may have additional information or clarification requests during the review period. The Bahama Redevelopment Advisory Committee is expected to meet on December 1, 2011, to recommend funding allocations.

In response to your email of 12-5-12, Request for Additional Information, the following repeats what Don Carey and I told the BVARC TIF Board at Thursday's meeting:

Our application indicated the correct breakdown of our Phase 3 request on Page 2 of our Phasing Plan, as revised 11-2-11, as follows:

Item C.2; The value of repair and paint as \$52,818

Item C.4: The value of the architect's fee as \$3,189 (5.5%)

Inexplicably, a summary sheet was inserted before the summary that indicated the cost of repair and paint to be \$46,818, and the architect's fee to be 17%. As I stated to the TIF Board, this should be removed for the application.

The breakdown of Item C.2, paint represents \$19,205 and Repair work represents \$33,613. I trust this is satisfactory, and I apologize for the mix-up.
