A RESOLUTION OF THE CITY COMMISSION  
OF THE CITY OF KEY WEST, FLORIDA,  
APPROVING THE ATTACHED CONTRACT -  
"AGREEMENT TO FURNISH A BICYCLE AND  
PEDESTRIAN MASTER PLAN TO THE CITY  
OF KEY WEST" ("AGREEMENT") WITH  
TOOLE DESIGN GROUP, LLC;  
AUTHORIZING THE CITY MANAGER TO  
EXECUTE NECESSARY DOCUMENTS UPON  
CONSENT OF THE CITY ATTORNEY;  
PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 16-310, the City Commission selected Toole Design Group, LLC as the top-ranked firm in response to RFP #16-006, Bicycle Master Transportation Plan Services, and directed City staff to enter into contract negotiations for approval by the City Commission; and

WHEREAS, negotiations are complete, and the City Manager recommends approval of the attached Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Contract - Agreement to Furnish a Bicycle and Pedestrian Master Plan to the City of Key West" between the City and Toole Design Group, LLC is hereby approved consistent with the terms and conditions contained in the solicitation and response received in RFP#16-006.

Section 2: That the City Manager is authorized to execute the necessary documents on behalf of the City with the advice and consent of the City Attorney.

Section 3: Funds for this project are allocated in FY 16-17 account No. 001-1501-515-3100, with grant funding anticipated through FDOT reimbursement budgeted in Account 001-0003-031-9000, as accepted in Resolution No. 16-101.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
