An Ordinance of the City of Key West, Florida, adopting an Ad Valorem Tax General Municipal Millage Rate for FY 2024-2025; Providing for severability; Providing for repeal of inconsistent provisions; Providing for an effective date. BE IT ORDAINED BY THE CITY OF KEY WEST, FLORIDA: That the final adopted ad valorem tax general municipal millage rate for FY 2024-2025 is hereby set at 2.0326 mills (\$2.0326 per thousand dollars of assessed property value). The 2024-2025 final adopted millage rate is equal to 6.00 percent more than the rolled back rate of 1.9175 mills (\$1.9175 per thousand dollars of assessed property value).
