This Business Impact Estimate is given as it relates to the proposed ordinance titled:

AN ORDINANCE OF THE CITY OF KEY WEST, FLORIDA, AMENDING CHAPTER 58 OF THE CODE OF ORDINANCES, ENTITLED "SOLID WASTE" BY AMENDING SECTION 58-66, TO AMEND THE DUMPING FEE OR TIPPING FEE FOR KEY WEST RESIDENTS, COMMERCIAL ESTABLISHMENTS AND LICENSED BUSINESS, AND TO ADD FEES FOR RECYCLING AND TIRE DISPOSAL; AMENDING SECTION 58-67 TO PROVIDE THAT FEES MAY BE ANNUALLY ADJUSTED ADMINISTRATIVELY BY A PERCENTAGE UP TO OR EQUAL TO THE ANNUAL CPI.
